Key information for civil society and enabling environment for CSOs

In this part of the Newsletter we will regularly inform about important information about the civil society that are undertaken and implemented by other stakeholders

In October the Government adopted its third Strategy for cooperation with and development of the civil society with action plan 2018-2020. The Strategy contains thirty one measures divided in three priority areas: Normative, institutional and financial framework for civil society development; Democratisation, active participation of the civil society in the social processes, in policy creation and monitoring with special focus on the EU integration process. Some of the measures foreseen with the Strategy are: changes to the Law on Associations and Foundations; changes to the Law on games of chance and entertainment games; establishing transparent model for state funding with establishing a fond for institutional development of CSOs and co-financing EU-funded projects...

<u>Download the Strategy and the Action Plan</u> (in Macedonian only)

In April the Council for cooperation with and development of the civil society was established as an advisory body to the Government for promotion of the cooperation, the dialogue and for stimulating the civil society development in the country. The Council comprises 31 members, 16 are CSOs' representatives selected on an open call and the remaining 15 members are from the state institutions. In the period 16^{th} April -15^{th} February, the Council held nine sessions and some of the issues discussed are: Council for cooperation with and development of the civil society; Participation of the public in the decision making process in the area of environment; Conclusions from the public debate on the reform of the manner of financing organisations of disabled people; proposal to the Law on social protection; development of proposal for a model for CSOs' involvement in the EU-accession process...

More about the competences, the work and the members of the Council (in Macedonian only)

The project "National Resource Centre for Civil Society Organisations" or shortly Civil Society Resource Centre is funded by the European Union and implemented by Macedonian Centre for International Cooperation and the project partners Association for Democratic Initiatives (ADI) from Gostivar and Media Plus from Stip. The project duration is 15.02.2018-14.02.2021 and the total budget for the project is 507.820 EUR.

The project overall objective is empowered civil society that actively takes part in decision making and contributes to strengthened participatory democracy in the country, whereas the specific objective is to provide services for building the capacities of CSOs to be effective and accountable independent actors and to contribute to environment that is conducive to civil society. The primary target group of the project are civil society organisations in Macedonia, however, the project will also target relevant state institutions and other civil society actors.

Three resource centres are opened in Skopje, Gostivar and Shtip.
