
Key information for civil society and enabling environment for CSOs

This section of the Newsletter is dedicated to important information for the civil society in the country undertaken by other stakeholders

The need to amend the Law on Donations and Sponsorships in Public Activities in accordance with the good practices of regulation of philanthropy in the European Union, recent changes in the tax treatment of CSOs, their role as employers, the new active labour market measures that can be used in order to increase employment in the country, were some of the topics discussed at the **Conference on laws suitable for CSOs** held on 23rd April 2019. The event was organised within the project "**Changes for Sustainability**" funded by the European Union and implemented by the Association **Konekt** in partnership with the Apollonia Foundation and the Center for Tax Policy.

From 8 to 12 of April, the annual **International Civil Society Week** was organised in Belgrade, co-hosted by **CIVICUS** the global civil society alliance and the Serbian Association Civic Initiatives with the support of Balkan Civil Society Development Network. This year's theme was "**The Power of Togetherness**".



The ICSW 2019 Programme focused on three tracks:

- **Bridges** exploring how the current regional and global civil society context is changing, and connect participants and strengthen collaboration;
- **Streets** looking at ways to build constituencies and deepen the skill sets needed for successful civil action; and
- **Stairs** seeking to identify ways to build and sustain collective impact, and connect local and global efforts.

European Economic and Social Committee organised its 7th **Western Balkans Civil Society Forum** in Tirana on 16-17 April 2019.

The main topics of the agenda were the role of CSOs in promoting regional cooperation (trade and investment, connectivity and people to people relations), the state of social dialogue, as well as enabling civil space in the Western Balkans. The Forum brought together approximately 180 participants, including a broad range of civil society representatives from the EU and the Western Balkans, as well as representatives of the EU institutions, international organisations and governments of the region.

A final declaration with recommendations from CSOs was issued at the end of the event.

The project "National Resource Centre for Civil Society Organisations" or shortly Civil Society Resource Centre is funded by the European Union and implemented by Macedonian Centre for International Cooperation and the project partners Association for Democratic Initiatives (ADI) from Gostivar and Media Plus from Stip. The project duration is 15.02.2018-14.02.2021 and the total budget for the project is 507.820 EUR.

The project overall objective is empowered civil society that actively takes part in decision making and contributes to strengthened participatory democracy in the country, whereas the specific objective is to provide services for building the capacities of CSOs to be effective and accountable independent actors and to contribute to environment that is conducive to civil society. The primary target group of the project are civil society organisations in the country, however, the project will also target relevant state institutions and other civil society actors.

Three resource centres are opened in Skopje, Gostivar and Shtip.
