# Organised visits of the Mobile Resource Centre

In May the Civil Society Resource Centre organised visits of the Mobile Resource Centre to Debar, Prilep and Probishtip.

The Council for cooperation with and development of the civil society was in the focus of the meeting with CSOs in Prilep. Key challenges of Probishtip organisations were lack of premises and trained staff in CSOs as well as the low interest for volunteering. The organisations in Debar pointed out that the largest risk is the sustainability and the brain-drain in the organisations. In addition, CSOs in Debar have problems with ensuring offices and equipment for their smooth operation.

### Key information for civil society and enabling environment for CSOs

On May 15, an event for the promotion of the national Social Enterprise Network was held in Skopje. At the event, a Declaration was signed by which all stakeholders expressed their readiness to contribute to the eco system for the development of social entrepreneurship in the country. The establishment of the network was initiated by the Association for Research, Communication and Development "Public"

At the conference Reform of the of the State Funding System for Civil Society Organisations

At the conference Reform of the of the State Funding System for Civil Society Organisations organized by Macedonian Centre for International Cooperation on May 22, it was stressed that the objectives of the improved reformed model for state funding of CSOs should be: to increase the funds intended for financing CSOs; to provide institutional support for CSOs; to provide co-financing of activities supported by other donors; to discontinue the practice of one-year and uncertain financing and to raise awareness and practice for multi-annual organisational and project support; to increase the size of individual grants; to promote transparency, effectiveness and accountability of the procedure for distribution of funds; to increase accountability and transparency of CSOs for the received state funds; to ensure adequate geographical distribution of state support for CSOs.

In May, several consultations of the Government with CSOs were organised for the preparation of the National Strategy for the Development of the Concept for One Society and Interculturalism. This consultative process will continue in June.

In May, the consultative process for the drafting of the Law on youth participation and youth policy started. Coalition of youth organizations SEGA and the National Youth Council of Macedonia are part of the working group for drafting the Law. Comments to the proposed Law can be submitted by June 30.

Regular and intensive cooperation, simplification of procedures for civic initiatives, updated lists for communication with civil society organizations, more information and more frequent regular meetings with CSOs were the main conclusions of the National Forum of CIVICA Mobilitas "Cooperation between the Parliament and CSOs" held on May 28, 2019

The project "National Resource Centre for Civil Society Organisations" or shortly Civil Society Resource Centre is funded by the European Union and implemented by Macedonian Centre for International Cooperation and the project partners Association for Democratic Initiatives (ADI) from Gostivar and Media Plus from Stip. The project duration is 15.02.2018-14.02.2021 and the total budget for the project is 507.820 EUR.

The project overall objective is empowered civil society that actively takes part in decision making and contributes to strengthened participatory democracy in the country, whereas the specific objective is to provide services for building the capacities of CSOs to be effective and

accountable independent actors and to contribute to environment that is conducive to civil society. The primary target group of the project are civil society organisations in the country, however, the project will also target relevant state institutions and other civil society actors.

Three resource centres are opened in Skopje, Gostivar and Shtip.
